GENERAL CONDITIONS OF SALE

1. The sale of each Lot offered at this auction is subject to the printed conditions contained in this catalogue and each Lot sold will be subject to either a Forestry Commission Standard Contract or a Memorandum of Agreement and Standard Conditions of Sale, dependant on the Vendor of each Lot, specimens of which may be obtained from the Vendors and/or the Auctioneers and which will be available for scrutiny in the auction rooms. The names and addresses for the Private Growers' Lots are given with the details of each Lot and the full addresses of the Forest Enterprise offices are listed at the end of these Conditions.
2. The Seller reserves the right to make one bid for each Lot (the reserve price), which bid shall be delivered to the Auctioneer in a sealed envelope before the commencement of the sale. A contract is formed when a Lot is declared sold.
3. The highest bidder shall be preferred (subject to the undisclosed reserve price) and shall be bound by these Conditions of Sale and shall initially sign a Forestry Commission Standard Contract or Memorandum of Agreement (dependant on the Vendor of any particular Lot) on the day of the sale. Confirmatory documents will be forwarded to the successful bidder as soon as possible thereafter.
4. The Seller reserves the right to withdraw Lots or to alter the published order of sale of the Lots. If such changes are made they will be announced by the Auctioneer before the sale commences.
5. The sum by which each offer must exceed the immediately preceding offer shall be at the discretion of the Auctioneer.
6. All Lots will be offered for sale on a lump sum basis, or price per cubic metre, other than those being offered on an end product basis when bids per tonne will be invited.
7. All bids shall be exclusive of Value Added Tax, which shall be added to the purchase price of each Lot at the appropriate time.
8. At the conclusion of bidding for a Lot, the appropriate sealed envelope will be opened and if the last bid equals or exceeds the reserve price, the Lot will be knocked down. If the reserve is not reached the Seller may endeavour, at the conclusion of the Auction and in the sale room, to negotiate a sale with the highest bidder provided the latter gives intimation to this effect.
9. The Auctioneers, Messrs. Newland Rennie Wilkins, shall be the judge of the sale with powers to determine all differences arising during the sale.
10. No Lot carries entitlement to the offer of continuity of supplies of timber outside the Terms and Conditions of the Contract.
11. The description of the trees in the Sale Catalogue is believed to be accurate but is not guaranteed. In all other respects the Purchaser is held as satisfying himself as to the description of the sale Lots.
12. Date of commencement of Contracts will be stated in the Special Conditions described with each Lot.
13. The completion dates for all Contracts are as indicated against each Lot in the Catalogue.
14. Payment conditions are as stated in the Forestry Commission Standard Contract/Sale Contract referred to in 1 above. Your attention is drawn to the clause in the specimen contracts which describes the normal terms of trading. Application of these terms, which is

at the sole discretion of the Vendor is subject to establishment of satisfactory credit worthiness.

15. Arrangements to inspect the timber should be made direct with the appropriate Forester/Agent, as indicated in the Catalogue. Purchasers will be deemed to have acquainted themselves with arrangements for access and constraints, if any, in respect of each Lot, details of which are also available from the Forester/Agent.

16. Special Conditions of Sale referred to in each Lot are additional to the General or Standard Conditions of Sale. Purchasers are deemed to have acquainted themselves with these Special Conditions whether referred to in the Catalogue or not, details of which are available from the respective Forester/Agent.

17. Latecomers to the Sale will be deemed to have acquainted themselves with the Conditions of Sale and copies of this Catalogue, containing these Conditions, are available in the Saleroom for this purpose.

18. Safety signs conforming to British Standard BS5378, which warn individuals of a hazard and/or prohibit entry are to be provided by the Purchaser and maintained to the satisfaction of the Vendor.

19. All users of chainsaws on Vendors' property will be required to hold an appropriate Certificate of Competence issued by the National Proficiency Tests Council (NPTC). Unit awards accredited by the National Council for Vocational Qualification (NCVQ) will be recognised by the Health and Safety Executive as having a status equivalent to the NPTC Certificates. Self employed chainsaw users are responsible for ensuring they acquire the necessary certificate of competence. Timber merchants, management companies, etc., who hold Vendors' contracts and employ chainsaw users on those contracts are responsible for ensuring that the operatives are certificated and all users will be required to produce evidence of certification.

The standard NPTC Clause, as per Forestry Commission Guidelines is as follows:-

“Chainsaw operators working on Forestry Commission land must have attained a Certificate of Competence issued by the National Proficiency Tests Council, NPTC. “Trainees” will be allowed to operate chainsaws on FC land for the purpose of gaining post training consolidation, prior to formal NPTC Certification, if they possess a valid Record of Training and Achievement issued by FASTCO. For the purposes of this Condition, a valid Record of Training and Achievement, is one issued post November 1993, and which is still current. The Purchaser will be responsible for ensuring Trainees undergoing consolidation of training are supervised in accordance with Paragraph 14 & 15 of the Health and Safety Executive's Guidance Note GS48”.

20. For contracts with a commencement date on or after 5 December 2002, machine operators undertaking operations included within the scope of the Forest Machine Operator Certification Scheme are required to have successfully completed the relevant assessments. Trainees will be accepted subject to agreement and must be registered with the Scheme.

21. Forest Enterprise has been successful in obtaining Certification of its forest estate. All timber on offer in this sale is covered by Chain of Custody Certification No SGS-COC-0358. This certificate was re-issued on 12 November 2004 under the QUALIFOR Programme by SGS Forestry.

Road Haulage of Round Timber Code of Practice Forest Enterprise Policy

It is Forest Enterprise policy to comply with all the recommendations contained within the Code of Practice with regard to its own practices and operations and to require a similar level of compliance from all private individuals and companies when they are operating on Forestry Commission land.

The main road network in Forestry Commission forests and woodlands is normally capable of taking fully loaded lorries weighing up to either 40 tonnes on 5-axles or 41 tonnes on 6-axles. All hauliers operating on Forestry Commission roads will be advised in advance of restrictions of any sort applying to the particular sections of the network which they are authorised to use.

It is expected of hauliers that all loading of timber will be in accordance with the recommendations of the Code of Practice, and that all loads will be properly secured before a lorry departs from the loading site.

The Code of Practice states that, from 1st January 1999, all road vehicles used for timber transportation should either be fitted with a load weighing device or be loaded by a machine so fitted. From that date onwards Forest Enterprise will award timber haulage contracts only to hauliers able to demonstrate that their lorry fleet is able to comply with this recommendation. Similarly Forest Enterprise will expect purchasers of roundwood from its own direct production sites, or of standing sales, and who are responsible for their own haulage arrangements to comply fully with the same recommendation. Exemptions will be granted only in exceptional circumstances, and only following prior agreement with local Forest Enterprise staff.

In accordance with the recommendation included in the Code of Practice, in no circumstances will Forest Enterprise make payments to a haulier for that part of a load more than one tonne in excess of gross vehicle weight for vehicles rated at 38, 40 or 41 tonnes g.v.w. In the case of smaller vehicles payments will be limited to that part of the load no more than 5% in excess of gross vehicle weight.

Enforcement of compliance with the Code of Practice will be through the contracts Forest Enterprise has with its timber customers and hauliers. The existing standard contracts covering purchase of timber allow for immediate termination of a contract if the train weight of any vehicle used by a timber purchaser exceeds the maximum prescribed, or for repeated breaches of any of the other recommendations of the Code of Practice. Future haulage contracts will contain similar provisions.

Forest Enterprise staff will use common-sense in the applications of sanctions, but those guilty of serious or repeated breaches of the Code of Practice can expect to have their contracts terminated and, if circumstances justify it, restrictions placed on their future freedom to operate on Forestry Commission land.
